SUMMARY

IT Services in the Netherlands industry profile provides top%li%line qualitative and quantitative summary information including: market size (value 2015%li%19, and forecast to 2024). KEY HIGHLIGHTS

The IT services industry is valued as the combination of the business process outsourcing (BPO) services market, the application services market and the infrastructure services market. Values include revenues generated from (a) signed deals that remain under contract and (b) new contracts signed within that particular calendar year.

The Dutch IT services industry had total revenues of \$19.2bn in 2019, representing a compound annual growth rate (CAGR) of 16.5% between 2015 and 2019.

The infrastructure services segment was the industry's most lucrative in 2019, with total revenues of \$10.6bn, equivalent to 55% of the industry's overall value.

The IT services industry is highly correlated with the gross domestic product (GDP) of a country.
