SUMMARY

IT Services in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2016-20, and forecast to 2025). The IT services industry is valued as the combination of the business process outsourcing (BPO) services market, the application services market and the infrastructure services market. Values include revenues generated from (a) signed deals that remain under contract and (b) new contracts signed within that particular calendar year.

The Scandinavian IT services industry had total revenues of \$28.1bn in 2020, representing a compound annual growth rate (CAGR) of 13.3% between 2016 and 2020.

The infrastructure services segment was the industry's most lucrative in 2020, with total revenues of \$16.9bn, equivalent to 60% of the industry's overall value
