Summary

Key Highlights

The IT services market involves the design, development, implementation, management, and support of information technology systems and applications for organizations. Market values include revenues generated from (a) signed deals that remain under contract and (b) new contracts signed within that calendar year.

The Scandinavian IT services industry registered revenues of \$27.9 million in 2023, representing a compound annual growth rate (CAGR) of 7.8% between 2018 and 2023.

The infrastructure services segment accounted for the industry's largest proportion in 2023, with total revenues of \$17 million, equivalent to 61% of the industry's overall value.

Sweden is witnessing an expanding ICT industry and accounts for a share of 40.0% share of the total IT spend in the Nordics, according to the data from NASSCOM, a not-for-profit industry association.
