#### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The IT services industry within the NAFTA countries had a total market value of \$462.2 million in 2019. The Canada was the fastest growing country, with a CAGR of 13.4% over the 2015-19 period.

Within the IT services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$418.7 million in 2019. This was followed by Canada and Mexico, with a value of \$31.1 and \$12.5 million, respectively.

The US is expected to lead the IT services industry in the NAFTA bloc, with a



value of \$709.5 million in 2024, followed by Canada and Mexico with expected values of \$56.1 and \$22.2 million, respectively.
