SUMMARY

BPO Services in Italy industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). KEY HIGHLIGHTS

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Italian BPO services market had total revenues of \$5,272.7 million in 2021, representing a compound annual growth rate (CAGR) of 4.9% between 2016 and 2021.

The vertical-specific BPO segment was the market's most lucrative in 2021, with total revenues of \$1,502.1 million, equivalent to 28.5% of the market's overall value.



The growing trend towards flexibility in outsourcing business processes among the small and large companies is expected to drive the BPO service market across the country.
