The road segment accounted for the industry group's largest proportion in 2022, with total revenues of \$78.6 billion, equivalent to 74.1% of the industry group's overall value.

The growth in the Japanese transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Japan reached 100.79 in January 2022, up from 99.48 in January 2021.
