#### **SUMMARY**

The NAFTA Jewelry & Watches industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

#### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The jewelry & watch retail industry within the NAFTA countries had a total market value of \$1,26,914.3 million in 2020. The Canada was the fastest growing country, with a CAGR of 0.8% over the 2016-20 period.

Within the jewelry & watch retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,19,412.0 million in 2020. This was followed by Canada and Mexico, with a value of \$5,121.4 and \$2,380.9 million, respectively.

The US is expected to lead the jewelry & watch retail industry in the NAFTA bloc, with a value of \$1,49,448.5 million in 2025, followed by Canada and Mexico with expected values of \$6,011.5 and \$3,170.9 million, respectively.
