The Asia-Pacific jewelry & watches market had total revenues of \$339,511.9m in 2018, representing a compound annual growth rate (CAGR) of 10.6% between 2014 and 2018.

The jewelry & watches segment was the market's most lucrative in 2018, with total revenues of \$240,630.7m, equivalent to 70.9% of the market's overall value.

The Chinese market is by far the largest is the region, accounting for 56.9% of its total value in 2018, therefore its performance is heavily reflected in the



regions as a whole.
