The German jewelry & watch retail market registered revenues of \$13,413.5 million in 2023, representing a compound annual growth rate (CAGR) of 1.9% between 2018 and 2023.

The jewelry & watch segment accounted for the market's largest proportion in 2023, with total revenues of \$7,683 million, equivalent to 57.3% of the market's overall value.

In 2023, the German jewelry & watch retail market recorded an annual growth of 6.2% fueled by factors such as reduced unemployment, improved standard of



living, and increasing consumer confidence index.
