The Indonesian jewelry & watch retail market registered revenues of \$6,699 million in 2023, representing a negative compound annual growth rate (CAGR) of 1.4% between 2018 and 2023.

The jewelry & watches segment accounted for the market's largest proportion in 2023, with total revenues of \$4,900 million, equivalent to 73.1% of the market's overall value.

In 2023, the Indonesian jewelry & watch retail market recorded an annual growth of 3.4%, fueled by factors such as declining unemployment, an improved standard of living, and a rising consumer confidence index.
