The market Includes gold jewelry, silver jewelry, and other precious jewelry like diamonds, platinum, precious stones (sapphires, emeralds, and rubies), pearls (natural and cultured), semi-precious stones (e.g. quartz, opal, topaz, amethyst, coral etc.), precious charms, brooches, cufflinks, body jewelry, precious hair accessories/headwear (tiaras) and fine watches.

The Singaporean jewelry & watch retail market registered revenues of \$5,106.4 million in 2023, representing a compound annual growth rate (CAGR) of 3.8% between 2018 and 2023.

The jewelry & watch segment accounted for the market's largest proportion in 2023, with total revenues of \$4,290.5 million, equivalent to 84% of the market's overall value.

In 2023, the Singaporean jewelry & watch retail market recorded an annual growth of 6.9% driven by factors such as reducing unemployment, rising GDP, and an increase in the consumer confidence index.
