Jewelry and Watches in Brazil

SUMMARY

Jewelry and Watches in Brazil industry profile provides top-line qualitative and quantitative summary information including: market size (value 2014-18, and forecast to 2023). KEY HIGHLIGHTS

The Jewelry, Watches and Accessories market includes gold jewelry, silver jewelry and other precious jewelry like diamonds, platinum, precious stones (sapphires, emeralds and rubies), pearls (natural and cultured) and semi-precious stones (e.g. quartz, opal, topaz, amethyst, coral etc.), fashion jewelry (non-precious jewelry), hair accessories, belts, hats, gloves, scarves, sunglasses and ties, plus watches.

The Brazilian jewelry and watches market had total revenues of \$6,343.8m in 2018, representing a compound annual growth rate (CAGR) of 4.4% between 2014 and 2018.

The jewelry and watches segment was the market's most lucrative in 2018, with total revenues of \$3,663.7m, equivalent to 57.8% of the market's overall value.

Due to political and economic crises, Brazilian consumers adopted a conservative attitude, preferring in general to cut their purchases of luxury items and expensive goods. Despite this, jewelry remains a fairly popular luxury item,

accounting for much of the growth that has been seen.
