SUMMARY

The Chinese jewelry and watches market had total revenues of \$193,249.1m in 2018, representing a compound annual growth rate (CAGR) of 13.6% between 2014 and 2018.

The jewelry and watches segment was the market's most lucrative in 2018, with total revenues of \$129,076.4m, equivalent to 66.8% of the market's overall value.

Chinese economy has transformed significantly in the past decade, economic prosperity has vastly improved the standard of living in the country and led to



rising incomes, which has led to a surge in the market.
