SUMMARY

The Jewelry, Watches and Accessories market includes gold jewelry, silver jewelry and other precious jewelry like diamonds, platinum, precious stones (sapphires, emeralds and rubies), pearls (natural and cultured) and semiprecious stones (e.g. quartz, opal, topaz, amethyst, coral etc.), fashion jewelry (non-precious jewelry), hair accessories, belts, hats, gloves, scarves, sunglasses and ties, plus watches.

The German jewelry and watches market had total revenues of \$11,388.4m in 2018, representing a compound annual growth rate (CAGR) of 2% between 2014 and 2018.

The jewelry and watches segment was the market's most lucrative in 2018, with total revenues of \$5,870.7m, equivalent to 51.6% of the market's overall value.

The increasing number if inbound international visitors drive has driven the demand for luxury, high end items in Germany.
