The Jewelry & Watches segment was the market's most lucrative in 2017, with



total revenues of \$79,851.2m, equivalent to 65.9% of the market's overall value.

In Europe, the market is already highly developed with many of the leading watch and jewelry makers coming from the region. Growth in Europe has been limited for a number of years now, but there are signs that the economic situation is beginning to improve, which can only be good for players in this market.
