The Kazakhstani banks industry group has expanded recently owing to several factors, such as a robust regulatory framework, a growing economy, increasing interest rates, and a highly skilled labor population. According to in-house



research, the real GDP annual growth of Kazakhstan stood at 2.8% in 2022.
