Summary

Key Highlights

Non-life insurance is typically defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event.

The Kazakhstani non-life insurance market had total gross written premiums of \$1 billion in 2022, representing a compound annual growth rate (CAGR) of 13.2% between 2017 and 2022.

The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$0.3 billion, equivalent to 35.4% of the market's overall value.

Non-life insurance coverage in the Kazakhstani population is relatively low. According to in-house research, in 2022, non-life insurance penetration (ratio of premiums to GDP) in Kazakhstan was 0.4%.
