The company produces gold in the doré form and is shipped for fine refining to a facility located at Southern Ontario. Furthermore, the company holds a portfolio of undeveloped deposits and highly prospective exploration properties. In addition, the company also operates the Fenn-Gib advanced-stage open-pit project. In early 2015, the company merged with Tahoe Resources Inc., and became the wholly owned subsidiary of Tahoe Resources Inc. Lake Shore Gold is headquartered in Toronto, Ontario, Canada.
