All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.



The global legal services market had total revenues of \$718.0 billion in 2021, representing a compound annual growth rate (CAGR) of 4.1% between 2016 and 2021.

Market production volume increased with a CAGR of 3.3% between 2016 and 2021, to reach a total of 7,979,900 practitioners of law in 2021.

The US legal services market is the largest in the world, accounting for 48.2% of the global market's value. Europe and Asia-Pacific account for 25.8% and 15.0%, respectively.
