All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2022 annual average exchange rates.



The global legal services market had total revenues of \$715.2 billion in 2022, representing a compound annual growth rate (CAGR) of 3.7% between 2017 and 2022.

Market consumption volume increased with a CAGR of 3.5% between 2017 and 2022, to reach a total of 8.2 million law personnel in 2022.

The market growth in 2022 is attributed to economic growth, the growing affordability of legal services backed by increasing income levels and employment, population growth, and rising demand for legal services among individuals, businesses, and government entities.
