Market consumption volume increased with a CAGR of 2.1% between 2019 and 2024, to reach a total of 77.9 thousand personnel in 2024.

The market growth is also supported by an increase in legal service fees, price



inflation, and transactional legal work, such as the sale, purchase, and merger of real estate; legal guidance and consultation; intellectual property affairs; business contracts; lease and rental agreements; securities transactions; and other legal services provided outside the court. For instance, according to GlobalData, the French real estate market grew by 3.0% in 2024.
