The UK legal services market recorded revenues of \$64.4 billion in 2024, representing a compound annual growth rate (CAGR) of 6.5% between 2019 and 2024.

Market consumption volume increased with a CAGR of 1.9% between 2019 and 2024, to reach a total of 215.4 thousand personnel in 2024.

The market growth in 2024 is attributed to economic growth, the growing



affordability of legal services backed by increasing income levels and employment, and the rising demand for legal services among individuals, businesses, and government entities. For instance, according to the Office of National Statistics, the nominal GDP of the UK increased by 1.2% in Q3 2024 compared to the previous quarter, with an annual increase of 4.0% when compared to Q3 2023.
