#### SUMMARY

The G8 Life Insurance industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

#### **KEY HIGHLIGHTS**

The G8 countries contributed \$1,607.6 billion in 2020 to the global life insurance industry, with a compound annual growth rate (CAGR) of 2% between 2016 and 2020. The G8 countries are expected to reach a value of \$2,042.7 billion in 2025, with a CAGR of 4.9% over the 2020-25 period.

Among the G8 nations, the US is the leading country in the life insurance industry, with market revenues of \$606.2 billion in 2020. This was followed by Japan and the UK, with a value of \$322.5 and \$253.3 billion, respectively.

The US is expected to lead the life insurance industry in the G8 nations with a value of \$771.8 billion in 2016, followed by Japan and the UK with expected values of \$453.0 and \$329.0 billion, respectively.
