The life insurance segment accounted for the market's largest proportion in 2023, with total gross written premiums of \$943.4 billion, equivalent to 87.9% of the market's overall value.

The growth in the Asia-Pacific life insurance & pension market is being driven by the increasing population of individuals aged 25 and above. As this demographic reaches key milestones in their careers and personal lives, such as marriage



and starting families, the demand for life insurance policies is on the rise. According to the United States Census Bureau, the population of individuals aged 25-29 years in Japan stood at 6.2 million in 2023, an increase of 0.3% from the previous year.
