The Irish life insurance & pension market recorded gross written premiums of \$19.8 billion in 2023, representing a negative compound annual growth rate (CAGR) of 16.6% between 2018 and 2023.

The pension/annuity segment accounted for the market's largest proportion in 2023, with total gross written premiums of \$14.5 billion, equivalent to 73.3% of the market's overall value.

The significant drop in GDP growth has created more uncertainty for consumers about their financial security. For instance, according to the Central Statistics Office, Ireland, the real GDP annual growth of Ireland stood at negative 5.5% in

2023 as compared to 8.6% in 2022. This negative economic outlook has discouraged consumers from spending more on financial protection and retirement planning.
