#### Summary

The marine freight sector includes revenues generated from the transportation of containers (only LoLo) and dry bulk cargo by sea and ocean-going vessels. The sector encompasses domestic and international freight, which, for the purposes of this report, is counted in the country of origin.

The Asia-Pacific marine freight industry recorded revenues of \$673.7 billion in 2023, representing a compound annual growth rate (CAGR) of 1.0% between 2018 and 2023.

The containerized segment accounted for the industry's largest proportion in 2023, with total revenues of \$598.9 billion, equivalent to 88.9% of the industry's overall value.

The Asia-Pacific region is the largest industry, accounting for 49.2% of the global marine freight industry in 2023.
