The company markets and underwrites specialty property and casualty insurance programs and products on both an admitted and non-admitted basis through a diverse network of independent retail agents, wholesalers, program administrators and general agents. MIG primarily operates in the US, where it is headquartered in Southfield, Michigan, and employs 954 people as on February 21, 2014.

The company recorded revenues of \$791.2 million during the financial year ended December 2013 (FY2013), a decrease of 20.6% compared to FY2012. The operating loss of the company was \$145.7 million in FY2013, as compared to an operating profit of \$1.3 million in FY2012. The net loss of the company was \$112.5 million in FY2013, as compared to a net profit of \$11.7 million in FY2012.
