Production volumes declined with a negative CAGR of 2.1% between 2018 and 2023, to reach a total of 450,694.1 thousand tonnes in 2023.

In 2023, the Brazilian metals & mining industry witnessed a slow growth in industry according to GlobalData, in 2023 iron production increased by 3.4%.
