SUMMARY

The North American metals & mining industry had total revenues of \$242.8bn in 2018, representing a compound annual growth rate (CAGR) of 0.2% between 2014 and 2018.

Production volumes declined with a CARC of - 2.2% between 2014 and 2018, to reach a total of 984.6 million metric ton in 2018.

The Iron & Steel segment was the industry's most lucrative in 2018, with total revenues of \$129.7bn, equivalent to 53.4% of the industry's overall value.
