Production volumes declined with a CARC of - 3.9% between 2014 and 2018, to reach a total of 11.5 million metric ton in 2018.

Saudi Arabia's Government is actively pursuing economic diversification away from oil. Consequently, non-oil sectors, including the metals and mining industry, have emerged as key drivers of growth in recent times. Mining is the third pillar of Saudi's economy which encourages investment.
