### SUMMARY

Metals & Mining in Thailand industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2014-18, and forecast to 2023). ### KEY HIGHLIGHTS

The metals & mining industry consists of the aluminum, iron & steel, precious metals & minerals, coal and base metal markets.

The Thai metals & mining industry had total revenues of \$5.4bn in 2018, representing a compound annual growth rate (CAGR) of 10.6% between 2014 and 2018.

Production volume increased with a CAGR of 0.7% between 2014 and 2018, to reach a total of 21.2 million metric ton in 2018.

Global price increases for tin, tungsten, niobium, tantalum, lead, zinc, gold and iron during 2017 helped recover lost industry value from 2015 despite production staying relatively the same.
