### SUMMARY

Metals & Mining in Belgium industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The metals & mining industry consists of the aluminium, iron & steel, precious metals & minerals, coal and base metal markets.

The Belgian metals and mining industry had total revenues of \$5.6bn in 2020, representing a compound annual rate of change (CARC) of -0.6% between 2016 and 2020.

Production volumes declined with a CARC of -6.5% between 2016 and 2020, to reach a total of 9.6 million metric tons in 2020.

The Belgian industry has suffered in recent years due to the imposition of tariffs on a number of EU products, including steel, by the US. This has contributed to a -24% drop in the production of this commodity between 2018 and 2020.
