Production volumes declined with a CARC of -13.3% between 2016 and 2020, to reach a total of 47.3 million metric tons in 2020.

Colombia has the largest coal reserves in South America and coal is incredibly important to country's wider economic performance. However, as global concerns about climate change continue to mount and countries around the world transition to sustainable and renewable energy sources, Colombia's

metals and mining industry is expected to suffer.
