SUMMARY

The metals & mining industry consists of the aluminium, iron & steel, precious metals & minerals, coal and base metal markets.

The German metals and mining industry had total revenues of \$40.5bn in 2020, representing a compound annual rate of change (CARC) of -1.8% between 2016 and 2020.

Production volumes declined with a CARC of -9.2% between 2016 and 2020, to reach a total of 156.2 million metric tons in 2020.

The metals and mining industry experienced severe disruption in 2020 due to the impact of the COVID-19 pandemic. Nationwide lockdown restrictions, self-isolation requirements, and social distancing measures have had an impact on productivity, with production volume down by -15.7% over the year.
