SUMMARY

The Mexican metals and mining industry had total revenues of \$27.1bn in 2020, representing a compound annual growth rate (CAGR) of 2.9% between 2016 and 2020.

Production volumes declined with a CARC of -5.9% between 2016 and 2020, to reach a total of 31.6 million metric tons in 2020.

The growth of the investment in infrastructure and machinery, along with the rising demand for consumer goods, has boosted the production of steel in Mexico. However, this has been somewhat offset by a series of tariffs on steel trade in recent years.
