SUMMARY

The metals & mining industry consists of the aluminium, iron & steel, precious metals & minerals, coal and base metal markets.

The Norwegian metals and mining industry had total revenues of \$2.3bn in 2020, representing a compound annual growth rate (CAGR) of 2.3% between 2016 and 2020.

Production volumes declined with a compound annual rate of change (CARC) of -4.6% between 2016 and 2020, to reach a total of 2.9 million metric tons in 2020.

Looking forwards, demand for materials such as iron and steel in the Norwegian industry is expected to be sustained by strong fiscal investment in construction and infrastructure projects, which will help to drive value growth.
