### SUMMARY

The Pakistani metals and mining industry had total revenues of \$1.9bn in 2020, representing a compound annual growth rate (CAGR) of 8.9% between 2016 and 2020.

Production volume increased with a CAGR of 10.4% between 2016 and 2020, to reach a total of 10.8 million metric tons in 2020.

Despite being the largest segment of the industry by production volume, demand for coal in Pakistan is expected to decline in the coming years as environmental concerns regarding the use of this commodity mount.
