SUMMARY

The metals & mining industry consists of the aluminium, iron & steel, precious metals & minerals, coal and base metal markets.

The South American metals and mining industry had total revenues of \$112.7bn in 2020, representing a compound annual growth rate (CAGR) of 4% between 2016 and 2020.

Production volumes declined with a compound annual rate of change (CARC) of -6.8% between 2016 and 2020, to reach a total of 128.4 million metric tons in 2020.

The metals and mining industry experienced severe disruption in 2020 due to the impact of the COVID-19 pandemic. Nationwide lockdown restrictions, self-



isolation requirements, and social distancing measures have had an impact on productivity, with production volume down by -22.3% over the year.
