SUMMARY

The Swedish metals and mining industry had total revenues of \$6.1bn in 2020, representing a compound annual growth rate (CAGR) of 5% between 2016 and 2020.

Production volumes declined with a compound annual rate of change (CARC) of -0.9% between 2016 and 2020, to reach a total of 7.9 million metric tons in 2020.

The Swedish industry has been adversely affected by the imposition of tariffs on a number of EU products, including steel, by US president Donald Trump in 2018.
