SUMMARY

Metals & Mining in Thailand industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). KEY HIGHLIGHTS

The metals & mining industry consists of the aluminium, iron & steel, precious metals & minerals, coal and base metal markets.

The Thai metals and mining industry had total revenues of \$3.7bn in 2020, representing a compound annual growth rate (CAGR) of 8.1% between 2016 and 2020.

Production volumes declined with a compound annual rate of change (CARC) of -3.6% between 2016 and 2020, to reach a total of 16.6 million metric tons in 2020.

The metals and mining industry experienced severe disruption in 2020 due to the impact of the COVID-19 pandemic. Nationwide lockdown restrictions, selfisolation requirements, and social distancing measures have had an impact on



productivity, with production volume down by -2.6% over the year.
