SUMMARY

The Dutch metals & mining industry had total revenues of \$7.3bn in 2018, representing a compound annual rate of change (CARC) of - 2.5% between 2014 and 2018.

Production volume increased with a compound annual growth rate (CAGR) of 0.4% between 2014 and 2018, to reach a total of 13.1 million metric ton in 2018.

Global price increases for the metals sector since mid%li%2016 has helped the industry value recover. A weaker US dollar since mid%li%2017 has helped to sustain major industrial metal prices.
