SUMMARY

Metals & Mining in Sweden industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2014-18, and forecast to 2023). KEY HIGHLIGHTS

The metals & mining industry consists of the aluminum, iron & steel, precious metals & minerals, coal and base metal markets.

The Swedish metals & mining industry had total revenues of \$6.2bn in 2018, representing a compound annual rate of change (CARC) of - 1.0% between 2014 and 2018.

Production volume increased with a CAGR of 0.4% between 2014 and 2018, to reach a total of 8.2 million metric ton in 2018.

The production of crude steel dropped by 8% in 2018 in comparison to the volume of steel produced in 2017. Projects to make steel and iron production less carbon intensive reduced productivity within the sector.
