SUMMARY

The UK metals & mining industry had total revenues of \$6.8bn in 2018, representing a compound annual rate of change (CARC) of - 15.2% between 2014 and 2018.

Production volumes declined with a CARC of - 17.5% between 2014 and 2018, to reach a total of 15.6 million metric ton in 2018.

The Iron & Steel segment was the industry's most lucrative in 2018, with total revenues of \$6.4bn, equivalent to 94.5% of the industry's overall value.
