SUMMARY

The Mexican airlines industry had total revenues of \$6.4 billion in 2021, representing a compound annual growth rate (CAGR) of -6.2% between 2016 and 2021.

Industry consumption volumes declined with a CAGR of -0.6% between 2016 and 2021, to reach a total of 79.9 million seats sold in 2021.

Mexico is dominated by two low-cost carriers, Volaris and VivaAerobus, as well as Mexico's sole full-service carrier Grupo Aeromexico.
