The bank credit segment accounted for the industry group's largest proportion in 2022, with total assets of \$356.5 billion, equivalent to 70.7% of the industry group's overall value.

According to the OECD, the long-term interest rates of Mexican banks had increased steadily during the historic period, from 7.5% per annum in December 2017 to 8.7% per annum in January 2023.
