Summary

The Mexican broadcasting & cable TV market had total revenues of \$5.7 billion in 2022, representing a negative compound annual growth rate (CAGR) of 0.6% between 2017 and 2022.

The TV subscriptions segment accounted for market's the largest proportion in 2022, with total revenues of \$2.9 billion, equivalent to 50.5% of the market's overall value.

The growth in the market is driven by the high television household penetration rate in Mexico. For instance, 95.3% of Mexican homes own at least one television set. Over the forecast period, the television household penetration is



expected to increase slightly to 95.6% in 2026.
