SUMMARY

Non-Life Insurance in Mexico industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-22, and forecast to 2027). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.

The Mexican non-life insurance market had total gross written premiums of \$18.1 billion in 2022, representing a compound annual growth rate (CAGR) of 9.1% between 2017 and 2022.

The Liability segment accounted for market's the largest proportion in 2022, with

total gross written premiums of \$6.5 billion, equivalent to 35.9% of the market's overall value.

In 2022, the growing Mexican inflation raises the cost of insurance for consumers and for non-life insurance companies in particular, higher claim expenses are a result of inflation.
