The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The mobile apps industry within the NAFTA countries had a total market value of \$1,32,524.6 million in 2018.The US was the fastest growing country, with a CAGR of 11.6% over the 2014-18 period.

Within the mobile apps industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,16,548.8 million in 2018. This was followed by Canada and Mexico, with a value of \$10,476.9 and \$5,498.8 million, respectively.



The US is expected to lead the mobile apps industry in the NAFTA bloc, with a value of \$1,84,618.3 million in 2023, followed by Canada and Mexico with expected values of \$16,676.9 and \$8,437.7 million, respectively.
