The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The movies & entertainment industry within the NAFTA countries had a total market value of \$24,385.6 million in 2023. The Canada was the fastest growing country, with a CAGR of -1.1% over the 2019-23 period.

Within the movies & entertainment industry, the US is the leading country among the NAFTA bloc, with market revenues of \$22,116.5 million in 2023. This was followed by Canada and Mexico, with a value of \$1,292.7 and \$976.3 million, respectively.

The US is expected to lead the movies & entertainment industry in the NAFTA bloc, with a value of \$34,308.3 million in 2028, followed by Mexico and Canada with expected values of \$2,070.9 and \$1,736.4 million, respectively.
