SUMMARY

The music & video segment accounted for the largest proportion of the market in 2020, with total revenues of \$304.2m, equivalent to 93.5% of the market's overall value.

The COVID-19 pandemic had a hugely detrimental impact on the movies & entertainment market throughout 2020. Movie theaters in many countries were

forced to close and the leading movie production companies suspended the release of their box office data. This is reflected in the huge decline seen in this market in 2020.
